1. WARNING & COMMUNICATIONS

- a. On 07/03/2024 in the township of Cameron a feed truck rolled over causing approximately 20 gallons of diesel to spill. Allied Co-op was contacted and arrived to offload the truck and asset with clean up. Fuel was kept out of the soil.
- b. On 07/14/2024 in Wisconsin Rapids a caller reported that a company was dumping Acetone, Ketone Peroxide, and MATP Resin into a nearby retention pond to avoid EPA regulations. It is unknown how much has been dumped into the pond. Warden Josh Litvinoff was notified.
- c. On 07/17/2024 in Wisconsin Rapids a spill of 250 gallons of Effluent was reported by ND Paper caused by a leak in the Effluent line. The substance leaked into the dirt and compacted gravel but was quickly contained and cleaned up.
- d. On 07/23/2024 in Wisconsin Rapids at Miller Cranberry Company, a spill of an unknown amount and substance was reported to the DNR Hotline. Additional information is unknown at this time.
- e. On 07/30/2024 in the Village of Milladore approximately 20 gallons of diesel was spilled due to a milk truck going into a ditch. The fuel was released into a resident's yard but wasn't flowing. Current clean up status is unknown at this time.

2. FEDERAL/STATE FUNDING

a. Submitted additional vouchers to Wisconsin Emergency Management for reimbursement from out Safe Room grant. We are still waiting on FEMA's determination if we will receive additional funding.

3. TRAINING

a. Director worked with IT, Dispatch and Communications on the trailer communications system.

b. Deputy Director attended various online training courses through Wisconsin Emergency Management.

4. Emergency Management Planning

a. Talked with a Foundation regarding funding for a vehicle barrier system. They are sending an application when it opens in December.

- b. Corresponded multiple times with Parks Director, Architects, and Contractor regarding the Safe Room Project. The doors and windows have been on back order for quite some time. They are now projected to ship the end of August.
- c. Spoke with the Army Corps of Engineers regarding the Grand Rapids/Saratoga Hydrology Study. They have finished going through the information that was sent to them and we have a conference call set up for next steps and site visit expectations on August 7th.

- Child Support Reimbursement
- Open Records fulfillment
- Held various meetings with end users of the Countywide Record Management System as it pertains to the Computer Aided Dispatch (CAD) system we use for all agencies as part of a total system refresh or change in vendor. These meetings will continue for several weeks.
- Continued working with our Phone Vendor (ModuCom) and CAD vendor to work our various bugs with our transition to NextGen911. There were mapping and call parsing disruptions.
- Met with furniture provider for CIP and DMA FY25 PSAP Grant figures.
- Completed DMA FY25 PSAP Grant. Grant is requesting just over \$400,000 worth of equipment/software/hardware/training/installation that would be covered at 90%, requiring only \$40,000 of County Funds. Both approved CIPs for this year and next are included as part of this grant.
- Attended Central Records Committee quarterly meeting and sub-committee meeting.
- Worked with Communications Director, Emergency Management Director and IT on improving Emergency Management trailer functionality. It was found that the cell phone modem needed some updating and when we have planned events a request for additional services through At&t/FirstNet is generally required in order to potentially gain increased services. A better option may be to purchase upgraded equipment. The Central Wisconsin State Fair is going to be a good test of all of the improvements/changes that were put in place.
- The Center participated in a T-Mobile NG911 PSAP Migration to improve network services in the area.
- Attended County Board meeting.
- Participated in Land Information Counsel meeting.
- Took 2 days vacation.
- Participated in Central Wisconsin State Fair Public Services meeting along with EM, Communications, Marshfield PD, Marshfield FD, Wood County Sheriff and Fair management.
- Began and continue to work on 2025 Dispatch Center Budget.
- Attended Wisconsin State NG911 GIS Monthly update call as they had information pertaining to Master Street Address Guide (MSAG), Automatic Location Identification (ALI) and Geographical Information System (GIS). I have been working diligently over the past year to ensure we meet the 98% match rate as directed by the Department of Military Affairs in order to go live on NG911. Our last check we were at 96%, but I made several updates that I believe get us over the 98% threshold, however it has not been verified by Intrado.
- Attended Operations Committee meeting via WebEx.
- Set up a booth during the National Night Out at Witter Field in Wisconsin Rapids to promote

dispatch and educate the community about 911 services.

- Attended Hub City Days wrap up meeting in Marshfield.
- Attended Community Partners meeting through Human Services for the new Crisis Intervention Line that is replacing the local service.
- Met with Human Services via WebEx for changes to After Hours Emergency Energy calls.
- Received notification of 2 impending retirements, 1 resignation of newly hired employee and extended a conditional offer to 1 canidate.

Remarks:

The IT department has again been phenomenal in working with us in the transition to the new laptops. One issue of concern was the use of Share Point. One point of contention was its difficulty in getting information in and out and its lack of ability to work on documents while in it. After discussing this with IT, we will no longer be utilizing Share Point for our records. Each person has a file on "L" drive under the Coroner. Everyone will now be able to work directly on, save or email documents directly from these folders, while being saved directly on the County system.

Chief Deputy Coroner Joling has accepted a new position as an EMS Director for an agency up north. As a result, his availability will be greatly reduced to weekends only. He has requested to stay on until he sees how it will work out.

Deputy Coroner Travis Patton has accepted a position as firefighter at McMurdo Station in the Antarctic. As such, in September he will be gone for approximately 6 months.

While I value all our staff, losing these two will be a challenge due to the fact their availability will be sorely missed. Both have always covered hours, taken calls on short notice and had the ability to run autopsies to Madison.

<u>**#2 – Calls for Service:**</u> North end Wood County received a total of 62 calls for service, 3 of which were requests to scene deaths. South end Wood County received a total of 35 calls for service, 8 of which were requests to respond to scene deaths. I received a total of 9 calls requesting follow-up information or requesting copies of reports.

#4 – Falls: In July, we had two cases of falls that resulted in the death of members of our elderly population. One was an 82-year-old male the other was s 74-year-old female. In both cases, the victim sustained significant closed traumatic head injuries.

<u>#8 – Suicide:</u> We responded to two more suicide cases in July. One individual had been recently diagnosed with a serious medical condition. The other was in the process of being evicted from his residence. Sadly, both leave behind loving family members who now have more questions that can't be answered.

#11 – Other: Our "other" case in July was an elderly gentleman who, while at home, succumbed from a foreign body airway obstruction. Sadly, he choked while eating dinner due to a stricture (narrowing) in his upper esophagus and was unable to get a large amount of food past it.

#12 – Pending: We have 1 case "pending" while we await toxicology reporting. We suspect that this will be a Fentanyl related death but need to wait for final toxicology to confirm this. We received several final autopsy and toxicology reports back and were able to update 5 of our previous "pending" cases and issue death certificates.


